- The IDT vehicle will be back next week. Jeffcom is excited to show the vehicle and suggested doing the next board meeting in person with the opportunity to show the vehicle. The IDT team has been identified, with 22 employees on the team.
- Hiring at Jeffcom has been slow. There has been a slight increase in applications the last week. There will be an academy 4/04/2022 will two new hires and a second academy April 18th with two laterals.
