- General Update and Overview
 - Thank you to everyone that participated in Jeffcom's CALEA virtual onsite assessment and to Jeffcom staff for your hard work. Jeffcom should receive the report later this summer with accreditation awarded in July.
 - Next academy is scheduled to start May 10th and Human Resources is currently doing testing and interviews for the August academy.
- Fire Operations Manager Vicki Pickett
 - Update on Emergency Notification System
 - The Emergency Notification system is funded by JCECA and shared with Jeffcom's partners at Westminster and Broomfield. The current system is the CodeRed system that was purchased in 2012.
 - Discussion on the requirements and limitations of CodeRed.
 - JCECA is currently looking at different emergency notification systems and is in the exploratory phase.
 - A coordinated marketing campaign from all the agencies would be very beneficial to raise public awareness to sign up for CodeRed.
 - Sheriff Shrader advocated for a comprehensive RFP to find a replacement system.

Emergency Notification System






Notification requirements

- Identify audience
- Craft message
- Send follow up message



Identify Audience



Craft the Message



It is April 3rd at 2:10 pm. Jeffco Sheriff has issued a shelter in place order for the area of the 4500 block of south Alkire Street and surrounding buildings. Police are contacting an armed suspect. There is a threat to your safety. If you are indoors, remain there. If you are outdoors, go indoors and remain there until further notice. Do not go outside and do not evacuate the area. Close and lock all doors and windows. Close all blinds and curtains. Stay away from windows and, if possible, move to the basement. Do not let anyone into your home or business and call 9 1 1 if there is somebody on your property who you do not know. Monitor local and social media for additional information. Take shelter now.

Code Red Notification Challenges

- It takes time!
- Only landline phones are automatically in the system
- Notifications are limited to incidents impacting their registered address
- Network capacity could impact message delivery
- Registrations can be delayed for verification prior to importing in the map
